WHEREAS, the Annual Budget for Gloucester Township FD No. 2 (the 'Fire District') for the fiscal year beginning January 1, 2026 and ending December 31, 2026 has been presented before the Board of Commissioners of the Fire District at its open public meeting of January 14, 2026; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$3,092,681.12 which includes an amount to be raised by taxation of \$2,915,397.90 and Total Appropriations of \$3,092,681.12; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on January 14, 2026 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2026 and ending December 31, 2026 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

WHEREAS, the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

WHEREAS, the adopted budget is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and allowable amount to be raised by taxation; and

WHEREAS, the Annual Budget as presented for adoption reflects Total Revenues of \$3,092,681.12 which includes amount to be raised by taxation of \$2,915,397.90, and Total Appropriations of \$3,092,681.12; and

WHEREAS, an election shall be held annually on the third Saturday of February in each established fire district to determine the amount to be raised by taxation for the ensuing year;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District at an open public meeting held on January 14, 2026 that the Annual Budget of the Fire District for the fiscal year beginning January 1, 2026 and ending December 31, 2026 is hereby adopted and, shall constitute appropriations for the purposes stated and authorization of Total Revenues of \$3,092,681.12, which includes amount to be raised by taxation of \$2,915,397.90, and Total Appropriations of \$3,092,681.12; and

The proposed 2026 Annual Budget calls for appropriations in the amount of \$3,092,681.12. Appropriations for the 2025 Adopted Budget were \$2,832,826.68. This is an increase of \$259,854.44. The District is expecting increases in all insurances, pension, and contractual salaries. The District is also anticipating hiring an additional 2 Firefighters in 2026 in which they will request a property tax cap levy referendum in the amount of \$228,179.88 on the February election ballot.

Unrestricted Fund Balance has decreased to \$76,197.73 in the proposed 2026 Annual Budget. This is a decrease of \$192,459.67 or 71.6% from the 2025 Adopted Budget. The District has lowered many appropriations in order to offset the anticipated increases in Cost Of Operations & Maintenance-Personnel. A majority of the anticipated increases will be offset by a property tax cap levy referendum. Restricted Fund Balance has decreased to \$0.00 in the proposed 2026 Annual Budget. This is a decrease of \$100,000.00 or 100.0% from the 2025 Adopted Budget. The District has decided not to fund their New Truck Fund for at least one year as it deals with anticipated increased Personnel costs. Other Revenues Offset with Appropriations-Other Offset Revenues #1-Gloucester Township FD 3 Shared Services has increased to \$41,750.00 in the proposed 2026 Annual Budget. This is an increase of \$11,750.00 or 39.2% from the 2025 Adopted Budget. The two Districts have agreed on a Shared Service increase due to the increased cost of labor and fringe benefits. Other Revenues Offset with Appropriations-Other Offset Revenues #2-Gloucester Township FD 1 Shared Services has increased to \$6,875.00 in the proposed 2026 Annual Budget. This is an increase of \$6,875.00 or 100.0% from the 2025 Adopted Budget. This is a new Shared Service that has been established by the two Districts in 2026. It will last at least for the First Quarter and may extend further into 2026. Other Revenues Offset with Appropriations-Other Offset Revenues #3-Fire Prevention & Suppression has increased to \$500 in the proposed 2026 Annual Budget. This is an increase of \$500 or 100.0% from the 2025 Adopted Budget. This budget figure was not correctly indicated in the 2025 Adopted Budget and is thus being corrected in the proposed 2026 Annual Budget to more accurately reflect actual results. Non-Life Hazard Fees has increased to \$18,000.00 in the proposed 2026 Annual Budget. This is an increase of \$3,000.00 or 20.0% from the 2025 Adopted Budget. Additionally, Permit Fees has decreased to \$1,000.00 in the proposed 2026 Annual Budget. This is a decrease of \$600.00 or 37.5% from the 2025 Adopted Budget. The District has adjusted both of these Revenue line items so that they are more in line with recent year actual results. Administration-Other-Other Assets, Non-Bondable #1-Computers has increased to \$12,625.00 in the proposed 2026 Annual Budget. This is an increase of \$2,700.00 or 27.2% from the 2025 Adopted Budget. The District is anticipating replacing some aged equipment. Cost of Operations & Maintenance-Personnel-Salary & Wages has increased to \$868,939.64 in the proposed 2026 Annual Budget. This is an increase of \$142,427.64 or 19.6% from the 2025 Adopted Budget. Additionally, Cost of Operations & Maintenance-Personnel-Fringe Benefits has increased to \$984,716.07 in the proposed 2026 Annual Budget. This is an increase of \$222,388.99 or 29.2% from the 2025 Adopted Budget. The

The amount to be raised from taxation for the proposed 2026 Annual Budget is \$2,915,397.90. The amount is 17.3% higher than the 2025 Adopted Budget. The District is going to utilize the maximum allowable amount to be raised by taxation for the 2026 Budget. The District is electing to qualify the increase in pension, shared services, and health care costs for the 2% cap exclusion. The District is anticipating hiring an additional 2 Firefighters in 2026 in which they will request a property tax cap levy referendum in the amount of \$228,179.88 on the February election ballot.

The District is anticipating hiring an additional 2 Firefighters in 2026 in which they will request a property tax cap levy referendum in the amount of \$228,179.88 on the February election ballot.
